Re: Potential Tax and Public Disclosure Dodging Loophole

Dear Chairs,

We write you this letter to bring your urgent attention to what appears to be a loophole in tax law, election law, or both in the hopes that your committees can investigate this practice further and prevent the public interest from being undermined.

Our committee is currently engaged in a campaign to keep Senate Bill 1137 (2022 - Senator Lena Gonzalez) from being overturned by the oil industry's well documented brazen attempt through "blatant lies" to mislead Californians¹ into circumventing our democracy with a

shameless referendum attempt. While the oil industry has a longtime practice of misleading Californians - which is the subject of our state's current lawsuit against the industry² - we have noticed a troubling new development in their current attempt to overturn the Legislature's work to keep oil drilling a safe distance from schools and neighborhoods.

The oil industry is engaged in an unprecedented level of obfuscation in their attempt to hide from the public the true source of tens of millions of dollars of propaganda and disinformation. Please see our recently updated report exposing their over \$11 million shadowy effort "Big Oil's Dark Money Ad Campaign Exposed". It makes sense the oil industry would want to hide the source of their propaganda effort due to their recent unprecedented profits from gouging Californians at the pump - a practice that the Legislature and Governor has been valiantly attempting to thwart⁴. Simply put, taking advantage of Californians is extremely profitable for the oil industry.

However, we have uncovered what appears to be a way that the oil industry is using to bilk Californians even further - by exploiting loopholes in state law, their referendum campaign is dodging proper public disclosure and perhaps even dodging taxes.

In October and November of 2022, a political committee formed to overturn SB 1137 and reported receiving loans of \$14.4 million from just 14 oil companies. To date, that committee has not reported making a single payment against that loan, nor has it reported paying any interest on these loans. Imagine the economic stimulus to our state if Californians were able to receive such favorable terms from local lenders.

Our campaign has consulted with legal counsel specializing in both elections and corporate tax law and the loans on their face appear to be legal. However, as no one can reasonably expect the multiple multimillion dollar companies to either "need" a loan nor be "paid back" on their loans, there must be another reason for these loans. At a minimum they are legitimate loans which may be paid back from the true contributors long after the ballots are cast - allowing the true contributors to dodge public disclosure. However, what may be more troubling is there is no existing law that expressly prohibits these companies from writing off these "failed loans" as a bad business investment and therefore avoiding taxes on that money. Could the oil companies really be greedy enough to want to overturn state law so they can drill for oil next to and underneath California schools and neighborhoods - while also avoiding taxes to do it?

The oil industry is currently engaged in a multimillion campaign to make the actions of the California Legislature and Governor irrelevant to their bottomless hunger for profit. One of the greatest powers in the arsenal of the people of California to protect themselves from out of control and greedy corporate interests rests with you and the Legislature's power to investigate, deliberate, and legislate. Simply put, we need your help.

If Big Oil has found a loophole to dodge both public disclosure and taxes, please close it. The public needs your protection from the insatiable greed of the oil industry.
